NOTICE OF BY-LAWS AMENDMENT

Notification of Bylaw Change - Chapter 9, Section 1, Bullet 2

Dear NCAGD Members, We hope this message finds you well.

This is an official notification regarding a recent change to the Bylaws of the NCAGD.

The following amendment was made to Chapter 9, Section 1, Bullet 2 of our Bylaws:

Old Text: "The board shall consist of one-two members at large from each defined district. [appendix 3] These members shall be put forward at the general session for election in the same manner as the officers. Process for elections shall follow the same guidelines as outlined in Chapter 11 Section 3 A. "

New Text: "The Board will consist of one district representative to serve as chair or memberat-large from each defined district. These members will be put forward at the general session for election in the same manner as the officers. The process for elections will follow the same guidelines outlined in Chapter 11 Section 1."
